# Meet our 2024 Foresters Forum Keynote Speakers

## Bruce Herbert - Owner of Team Alchemy System

### **Kurt Dyroff - National Wild Turkey Federation**



Kurt Dyroff is Co-CEO of the National Wild Turkey Federation (NWTF). Founded in 1973, the NWTF is a nonprofit organization whose mission is to conserve the American wild turkey and preserve the country's hunting heritage. Appointed to his Co-CEO role in May 2022, Dyroff leads mission-related duties for the NWTF, including conservation and government affairs, finance and accounting, and general business support. Dyroff has a proven record of successful staff and program management across the country including the development of both national and regional level partnerships with public, private, and non-governmental partners as well as with private landowners. Dyroff is a graduate of The Pennsylvania State University where he earned a Bachelor of Science degree in Civil Engineering with a minor in environmental engineering. Dyroff also is a fellow of the National Conservation Leadership Institute, professional member of the Boone and Crockett Club, and board members of the Council to Advance Hunting and the Shooting Sports. Dyroff was born and raised in the mountains of north-central Pennsylvania where he was introduced to the turkey woods at an early age. An avid hunter and fisherman, Dyroff currently resides in Sandpoint, Idaho with his wife and their two children.

### **Brian Luoma - The Westervelt Company**



A native of Fort Bragg, California, Mr. Luoma received his bachelor's degree in Forestry from Humboldt State University in 1986 and has been a Registered Professional Forester in California since 1990. Prior to joining The Westervelt Company, Mr. Luoma held multiple positions over a 29-year career with the Louisiana-Pacific Corporation ranging from forestry and procurement to structural panel manufacturing and business general management at the executive level. Over the course of his LP career, he lived and worked in Eureka California, Hayden Lake Idaho, Hayward Wisconsin and Nashville Tennessee. # Meet our 2024 Foresters Forum Session Speakers

## Erika Eidson - Forest Health Specialist



Erika grew up in the Midwest and received her undergraduate education at the University of Minnesota with a double major in Geography and Environmental Science, Policy and Management. During her undergraduate education, She worked in a tree-ring research laboratory and conducted experiments that used tree rings to look at past forest disturbances. Following graduation, Erika moved out west and worked for the Colorado State Forest Service doing Forest Inventory and Analysis. She later spent two years as an arborist diagnosing sick trees and performing hazard tree analysis for the City of Aurora, CO. During her time there, the emerald ash borer was discovered in Colorado for the first time. Erika returned to school in 2015 to pursue a master's degree in

Forestry at Utah State University in Logan, UT. Her thesis work focused on bark beetles and tree resistance. She has worked as a Forest Health Specialist for the Idaho Department of Lands since June 2017, where she advises landowners and forest managers on insect and disease issues, performs public outreach and education, and coordinates insect population monitoring surveys.

## Blake Henning - Rocky Mountain Elk Foundation



Blake has served in his current role since 2010, providing leadership to the organization's conservation, access, elk restoration, hunting heritage and government affairs programs. He has been with RMEF since 2000 when he was hired as the Regional Director for Wyoming. Since moving to RMEF HQ in 2005, he has held several positions involving ranch and land management, fundraising, and volunteer leadership. Henning has been active on a federal advisory committee on hunting and conservation policy since 2018 and in 2020 served as Chairman of American Wildlife Conservation Partners, a group of nearly 50 hunting and wildlife organizations. Blake's interest in conservation and hunting first began while growing up on a farm in

southeast Nebraska. He holds a B.S. in Wildlife Management and agriculture from the University of Nebraska and an M.S. degree in Wildlife Biology from Kansas State University.


## Blake Manley - University of Idaho Experimental Forest



Blake Manley is a 4th generation logger from Eastern Oregon. He is a graduate from the University of Idaho and a former Forest and Natural Resources teacher at Sweet Home High School. Currently Blake is the Program Manager of Workforce Development at the University of Idaho in the College of Natural Resources. Blake has a great deal of experience in the forest products industry, from logging and log buying to mill supervision. His biggest impact came during the Covid Pandemic when he created his hit *YouTube* series "Manley Jobs". This online platform of job shadowing provides young people with a glimpse of jobs not always represented in the regular classroom. He has been the Keynote speaker at both the Oregon Logging Conference and the Intermountain Logging Conference, been on the nationally recognized Fox News program "Fox and Friends" and spoken at more than handful of other nationwide events on forest education.

## David Johnson - Co-Author of "Cougars on the Cliff"



David Johnson is a former regional roving reporter-columnist for the Lewiston Tribune in Lewiston, Idaho. He most recently co-authored, with Dr. Maurice Hornocker, a memoir titled *Cougars on the Cliff: One Man's Pioneering Quest to Understand the Mythical Mountain Lion*. The book, published by Lyons Press, chronicles Hornocker's groundbreaking cougar study in the Big Creek drainage of what is now the Frank Church River of No Return Wilderness Area. Johnson, who lives in Moscow, Idaho, with his wife Linda Weiford, holds bachelors degrees in journalism from the University of Idaho, and wildlife management from the University of Minnesota.

## Steve Bryant - Federal Law Enforcement Officer, USFS



Steve Bryant is a Federal Law Enforcement Officer for the United States Department of Agriculture Forest Service, Law enforcement & Investigations with 24 years of public service, 16 of which as a law enforcement officer. Steve was born in Indianapolis, Indiana and studied English literature and composition at Indiana University. He started his career with the U.S. Forest Service as a firefighter in 1999 on the Pike National Forest in Lake George, Colorado. From 1999 until 2007 he worked as an engine captain as well a crewmember on hotshot and helitack crews. When the fire season was over, he would volunteer with other U.S. Forest Service resources marking and cruising timber and

assisting with recreation and range where needed. In 2007, he was hired as a U.S. Forest Service Law Enforcement Officer and moved to Moscow, ID. where he patrols the Nez Perce Clearwater and Idaho Panhandle National Forests. In his tenure as a law enforcement officer, Steve has had experience investigating complex timber theft and wildland fire investigations, archaeological and paleontological crimes, illegal mining, manufacturing and trafficking of illicit drugs on federal lands and search and rescue operations. He is married to his wife Angela and they have three teenage children. Aside from law enforcement duties, he also lectures at the University of Idaho for the College of Natural Resources and frequently speaks to schools and civic groups about the mission of the U.S. Forest Service and the role the agency plays in our community.

## Meet our 2024 Foresters Forum SFI Session Speakers

### Greg Latta - University of Idaho



Greg is a Research Associate Professor of Forest Economics and Director of the Policy Analysis Group at the University of Idaho. Dr. Latta's research focuses on the application of economic optimization models for policy analysis, with extensive experience in the forestry, land use, bioenergy, and climate policy domains. He holds a bachelor's degree in economics from the University of California at Santa Barbara, a master's degree in forest resources from Oregon State University and a Ph.D. in forest and resource economics from the Norwegian University of Life Sciences. He is co-author on multiple forest carbon offset methodologies and one of the founders of the Forest Carbon Quantification Consortium of researchers focused on scientific analyses designed to inform offset methodologies being developed and applied across registries.

### Dan Van Ostenbridge - Finite Carbon



Dan Van Ostenbridge is Finite Carbon's Director of Digital Platforms. He oversees the design, development, and operation of technology platforms that support the creation, management and marketing of carbon offset projects, such as Finite Carbon's CORE Carbon.® The CORE Carbon platform supports LandYield's program for entry into the carbon market using the Small Non-Industrial Private Landowner methodology from the American Carbon Registry. This combination opens carbon markets to landowners with as little as 40 acres of forest ownership.

## **Gordy Mouw - Director of Network Relations, Sustainable Forestry Initiative**



Gordy engages the SFI community to leverage the work of SFI Implementation Committees across the U.S. and Canada. He focuses on demonstrating the value of this work for SFI Certified Organizations. His career in forest certification began in 2004 and includes experience on both sides of the border. He led certification efforts that implemented chain-of-custody, fiber sourcing and forest management certifications at Stora Enso, NewPage and Verso. Gordy has served on 12 different SFI Implementation Committees throughout the Great Lakes region, the U.S. East Coast and Southeast. Gordy is a graduate of Michigan Technological University's School of Forest Resources and Environmental Science.

## **Jim Colla - Bureau Veritas**



Jim is a career forester who started out fighting fires in Idaho in 1977, at what is now a historic USFS ranger station.
