**Rebecca Barnard** is the Forestry Certification Manager for Sappi North America, Inc. (SNA). Rebecca manages Sappi's FSC®, SFI® and PEFC Chain-of-Custody certificates, FSC Controlled Wood Certificate and SFI Fiber Sourcing Certificate. Rebecca provides training, support and strategic direction on certifications to Sappi staff and customers, domestically and globally. She also is leading SNA's U.S. Lacey Act compliance and strategic response and compliance efforts to the new European Union Deforestation Regulation (EUDR). # 2026 Speakers



**Lennard Joe**, RPF is Chief Executive Officer, BC First Nations Forestry Council. Lennard Joe, (Traditional name of Suxwsxwwels, meaning Grizzly Man) brings over 30 years of natural resources and business experience into his current roles. He is a Registered Professional Forester, a member of the Nlaka'pamux First Nation, and CEO of the BC First Nations Forestry Council. Lennard is actively involved in the transformation of the forest sector within his territory as well as throughout Canada and the world. Living in balance Lennard carries the corporate knowledge of his nation and continues to practice its protocols and traditions. His role as an Indigenous Professional Forester has opened doors in Indigenous Governance, Provincial and Federal government, Industry, Academia, and Forest Certification.

Lennard also plays a key role with the Sustainable Forestry Initiative (SFI) since 2011, having served on its Resources Committee his primary goal was to incorporate Indigenous representation throughout the Standards revision process, and was successful in enshrining the Respect for Indigenous Rights and Traditional Knowledge as a standalone Objective in SFI's 2015 Forest Management Standard. Lennard has been a member of the SFI Board of Directors since 2018 and in 2023, received the SFI President's Award alongside other leaders for his contributions to advancing Indigenous relations within SFI's certification standards and governance.



**Nicholas R Kager** is originally from Washington. Nicholas has worked in Cultural Resource Management and Compliance for the Schitsu'umsh (Coeur d'Alene Tribe) since 2018 and has been working for Tribal entities (Fish/Wildlife/Forestry) for 12 years collectively. He is considered a Renaissance man as he embraces all fields of study in order to advance the THPO office. Nick holds a BS certificate from RSVRRO (Reservation School of Poverty and Racially Restricted Opportunities). As THPO, he is tasked with preserving, protecting and promoting Schitsu'umsh culture and cultural resources, as well as ensuring compliance with the National Historic Preservation Act on behalf of all residents of the Coeur d'Alene Reservation. In order to do this, his routine consists of continually re-educating his Federal partners about the Federal Trust responsibility that their agencies are mandated to uphold.



**Julia Lauch** works for the Idaho Department of Lands as the State Forester and Division Administrator for Forestry and Fire. She has 25 years of experience in wildland fire and forestry with state natural resource agencies. She spent 11 years with the Oregon Department of Forestry in various forestry and fire positions, prior to joining IDL in 2011. She helped establish Rangeland Fire Protection Associations in Idaho; spent a couple of years as the Regional Operations Chief, South; and was the Deputy Fire Chief, Operations prior to the position she now holds. **Blake Manley** is a fourth generation logger turned educator. He got his start in the woods in 1999 as a knotbumper for his dad. After college he has been involved directly in the forestry sector as a log buyer, forester, logger and as a teacher of forestry and natural resources at Sweet Home High School in Oregon for 5 years. After a brief time at the University of Idaho in workforce development, Blake now works directly with loggers to find solutions in labor scarcity. His passion to help young people find good jobs after high school set him apart from his peers as an educator. During the pandemic he started a YouTube series called "Manley Jobs." Distance learning wasn't working for hands-on classes and this was one way to reach students on their own level. The series has been featured nationally by media outlets such as FoxNews. **Brian Rupp** is an experienced forester and log buyer with over a decade of hands-on experience in the timber industry, spanning procurement, quality control, and fiber logistics across the Pacific Northwest and Alaska. He currently serves as a Forester and Log Buyer for Idaho Forest Group in Grangeville, Idaho, where he purchases timber sales from the U.S. Forest Service and Idaho Department of Lands, manages contractor operations, and oversees quality control and day-to-day log deliveries to the mill. **Jon Songster** has been with Idaho Department of Lands since 2016, playing a key role in advancing active forest management on federal lands in Idaho under the Good Neighbor Authority. Prior to joining the department, Jon gained diverse experience in natural resources working with small private forest landowners and managing industrial timberlands in the Inland Northwest. He holds degrees in Forestry and Forest Products from West Virginia University and the University of Idaho.



**Sean Steinebach** has built a career at the crossroads of forestry, collaboration, and community engagement. A 2001 graduate of the University of Montana with a B.S. in Forest Resource Management, Sean began with hands-on logging experience as a faller and equipment operator, giving him a deep appreciation for the challenges of the timber industry. In 2004, he joined Sun Mountain Lumber as Administrative Forester, where he helped guide sustainable forestry practices and strengthen the company's partnerships with federal land managers. From 2009 to 2021, Sean served with the Montana Department of Natural Resources and Conservation as a Service Forester, where he advanced the Good Neighbor Authority, supported private landowners, and gained extensive experience in wildfire management, including a role as Crew boss for the Montana State Prison Inmate Fire Crew. Sean returned to Sun Mountain

Lumber in 2021 as Outreach Forester and Residuals Manager, a multifaceted role that combines agency relations, forest policy, and infrastructure development. Sun Mountain Lumber in Deer Lodge and Livingston collectively employ nearly 300 Montanans and rely heavily on federal timber supply, making Sean's work with collaborative groups and policymakers essential to the vitality of Montana's forest products industry. He currently serves as Co-chair of the Beaverhead-Deerlodge Working Group, board member on the American Forest Resource Council, Montana Wood Products Association Montana Forest Collaboration Network, and participates in the Lolo Restoration Committee. Known for his ability to connect diverse stakeholders, Sean emphasizes cooperation and effective communication to find common ground in forest management. Beyond forestry, Sean once made his mark in Seattle's grunge music scene, an experience that deepened his appreciation for creativity and collaboration—qualities he brings to his work today. His career reflects a commitment to forest health, wildfire risk reduction, rural jobs, and ensuring Montana's forests remain resilient for future generations.



**Lindsay Tighe** serves as Chief of the Shackan Indian Band and General Manager of Stuwix Resources Joint Venture, a unique forestry enterprise collectively owned by eight First Nations in British Columbia's Nicola Valley. This governance model exemplifies Indigenous-led resource management, where cultural values and traditional knowledge are integrated into modern forestry practices. Under Lindsay's leadership, Stuwix has pioneered collaborative approaches to sustainable forest and resource management, including initiatives that reduce wildfire risk, enhance forest utilization, and create economic opportunities for Indigenous communities. His work demonstrates how Indigenous leadership can shape innovative, environmentally responsible solutions with broad relevance.

**Chad Washington** joined the Oregon Forest Industries Council in 2024 and brings nearly a decade of experience in forest planning, stewardship, and sustainability. His background includes managing Sustainable Forestry Initiative® certification, leading stewardship and community outreach efforts, and serving in a range of leadership and advisory roles, including the Oregon Governor's Wildfire Programs Advisory Council and chairing the Oregon Department of Fish and Wildlife's Private Forest Accord Mitigation Advisory Committee. Chad focuses on effective professional communication as a tool to support collaboration, informed decision-making, and successful natural resource management.



**Jill Wagner** is originally from Iowa, Jill has worked in Cultural Resource Management and Compliance for the Schitsu'umsh (Coeur d'Alene Tribe) since 2004 and has been the Tribal Historic Preservation Officer for 15 years. She has 40 years experience in her profession ranging from field archaeologist, research linguist, and university professor, to preservation officer. Jill holds a BA in Linguistics, along side her BS, MA and Ph.D. in Anthropology. As THPO, she is tasked with preserving, protecting and promoting Schitsu'umsh culture and cultural resources, as well as ensuring compliance with the National Historic Preservation Act on behalf of all residents of the Coeur d'Alene Reservation.



**Tom Whalen** is the founder/operator of Red Squirrel Security, an LLC working in Washington and Idaho for the past six years. Prior experience includes 31 years as a Sr. Conservation Officer for Idaho Fish and Game. At IDFG, Tom earned awards for both enforcement and wildlife education, ranging from recognition for work done in wildlife crime cases to conceptualizing and co-producing an award winning music video focused on the life-history of bull trout. Tom served specifically as the Bull Trout Officer for 19 years, which was a part of a larger collective formed under the Cabinet Gorge/Clark Fork River Settlement Agreement. The Federal Energy Regulatory Committee recognized this collaborative as the best mitigation program in the U.S. for 9 years running. Tom graduated from Purdue University in 1982 with a B.S. in Resource Management. Tom has experience as a whitewater river guide and as an accidental free-climber (once).
